Mr. Horacio Juarez updated the board on the progress of the district projects underway; the blending tank, Ikard Lift Station and the property adjacent to the lift station.

13. General Manager Update

- The collection rate for January was 98% with 47 cutoffs; 13 remain unpaid.
- The cutoff date was extended from Wednesday, February 21st to Monday the 26th due to the internet being down on the 5th and the 6th of February; we were unable to accept payments over the phone or online. Spectrum was not able to repair damaged line until late on February 5th.
- The system will be down again either this month or next due to computer and server change outs.
- On February 8th, 9th, and 12th, members of Peña, Briones, McDaniel and Company were in our offices gathering documentation for the 2023 financial audit. They will present the concluded audit at next month's regular board meeting.
- We are now hiring an office clerk; the opening has been posted.
- Grant writer, Mr. Omar Martinez submitted the Watersmart Grant application on Monday, February 19th. The Reclamation expects to contact potential award recipients in the summer of 2024.
- The community is invited to attend an Easter Egg Hunt, hosted by the Peter J. Herrera patrol station, at Veterans Park on Saturday, March 16th.
- Mr. Horacio Juarez submitted the Emergency Preparedness plan to TCEQ and it was approved.

Field Manager Update

- Pumped 23 million gallons from well #7; water loss is at 6% for January and TDS is at 621.
- Sewer Manhole Lining is halfway done and should be finished by next week.
- CC Camp—Joel Apodaca took the lead on this project.
 - Expanded building; all cement, welding and plumbing work done in house.
 - Alpha Southwest equipped well. Joe Padilla did electrical work.
 - o Project 98 % complete. Waiting on new booster pump.
- Current reports due by March; Tier 2, chemical thresholds report and the yearly Water Survey report.
- Digital Meters; field operators will continue installing residential meters this month.
